As part of the preparations for the implementation of Civil Parking Enforcement across Caerphilly County Borough, we are now in a position to progress the Traffic Regulation Order to consolidate the off-street parking places traffic regulation orders. As part of this process, we are required to consult all Statutory Consultees before advertising the new Order in the press.

The ~~attached~~ below draft notice detailing the effect of the consolidation order will be advertised in the press in the next few weeks. In addition to consolidating the existing orders, it is proposed to regulate the use of the following car parks (no charges or maximum time limits will apply at these locations):

- Caerphilly Station Car Park
- Newbridge Station Car Park
- Bargoed Gateway Car Park
- Aber Station Car Park
- Energlyn and Churchill Park Station Car Park
- Pengam Station Car Park
- Bargoed Station Car Park
- Risca Station Car Park
- Ystrad Mynach Station Car Park

This exercise is being carried out in order to standardise all existing Orders which is required as part of our application to Welsh Government, to enable effective and consistent enforcement across the Borough.

## **CAERPHILLY COUNTY BOROUGH COUNCIL OFF-Street Parking Places Consolidation Order 2019**

NOTICE is hereby given that the Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulations Act 1984 and the Traffic Management Act 2004 and all other enabling powers and after consulting with the Chief Officer of Police propose to make the above Order the effect of which will be:

In preparation for Caerphilly County Borough Council assuming responsibility for Civil Parking Enforcement, it is proposed to consolidate all restrictions within the existing off-street parking places Traffic Regulation Orders. The following orders will be revoked in their entirety:

- Caerphilly County Borough Council (Off-Street Parking Places) (Pay and Display and Limited Waiting) Order 2016
- Caerphilly County Borough Council (Off-Street Parking Places Number 2) Order 2004
- Caerphilly County Borough Council (Off-Street Parking Places Number 3) Order 2007
- Caerphilly County Borough Council (Cwmcarn Forest) (Off-Street Parking Places) Order 2012
- Caerphilly County Borough Council (Country Parks) (Off-Street Parking Places) Order 2014

It is also proposed to control the use of the following off-street parking places (no parking charges or maximum time limits will apply):

- Caerphilly Station Car Park
- Newbridge Station Car Park
- Bargoed Gateway Car Park
- Aber Station Car Park
- Energlyn and Churchill Park Station Car Park
- Pengam Station Car Park
- Bargoed Station Car Park
- Risca Station Car Park
- Ystrad Mynach Station Car Park

Within all off-street parking places, it will be an offence to:

- Park in a loading area during restricted hours without reasonable excuse
- Park without payment of any relevant parking charge
- Use a vehicle in a parking place in connection with the sale of offering or exposing for sales of goods
- Park for longer than the maximum permitted period
- Park in a restricted area
- Park after the expiry of time paid for in a pay and display car park
- Park in a pay and display car park without clearly displaying a valid ticket
- Park in a permit bay without clearly displaying a valid permit
- Park beyond the bay markings
- Park in a disabled person's parking space without clearly displaying a valid disabled persons badge
- Park a vehicle which exceeds the maximum weight permitted
- Return to a parking place sooner than permitted
- Park in an area not designated for that class of vehicle
- Park causing an obstruction
- Park in a car park when closed
- Park in a parking place for a purpose other than the designated purpose of that parking place
- Park with engine running where prohibited

A copy of the proposed Order, a statement of the Council's reasons for making the Order and maps showing the affected lengths of roads may be inspected at the offices of Caerphilly County Borough Council (address shown below) during normal office hours (Monday to Friday).
