Welsh Government – Appropriate Sum under Section 137(4)(A) of the Local Government 8 Act 1972 Section 137 Expenditure: Limit for 2018-19

This is to notify you that the appropriate sum for the purposes of section 137(4)(a) of the Local Government Act 1972 (the 1972 Act) for Community and Town Councils in Wales for 2018-19 is £7.86.

Section 137(1) of the 1972 Act permits each Community or Town Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of and will bring direct benefit to the area or any part of it or all of some of its inhabitants, providing that the benefit is commensurate with the expenditure. Community and Town Councils are also permitted under section 137(3) to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2017-18 will be £7.86 per elector.

13,616 electors (as at Jan 2018 CCBC) x £7.86 = £107,022
