Chair Cllr Martyn James welcomed everyone to the meeting and wished all a happy new year.

## 125 Apologies

Apologies were received from Cllr C Bezzina and Cllr R E Osborne due to other commitments, Cllr T Parry due to attending a meeting with the Police, Cllr S Griffiths and Cllr W Griffiths due to illness.

**Resolved:** Council agreed that Cllr S Griffiths' continuous leave of absence be extended by a further 6 months. Clerk to write to Cllr S Griffiths confirming Council's decision and with our very best wishes for a speedy recovery.

#### 129 Matters Arising

Minute No. 114 Lewis School Pengam – Luncheon Club

Cllr J Pritchard had attended the luncheon and reported that prices for a 2 course meal had increased to £3.50 and numbers had dwindled. Members agreed that it continued to be an excellent initiative building bridges between the young and older generation.

**Resolved:** Council agreed to subsidize £1.50 per meal up to £3,000 per annum under projects commencing Wednesday 14<sup>th</sup> February 2018. Clerk will contact Assistant Head Teacher Mr Mike Oliver and advertise on social media.

# 131 Precept 2018/19

D) Proposed Budget for 2018/19 showing 2% and 3% increases discussed and noted. Members agreed that following end of year accounts, reserves will be discussed further and earmarked for potential projects.

**Resolved:** Council agreed a 2% increase in precept, increasing Band D equivalent dwellings to £14.92 per annum, an increase of 0.29p. Thus providing the Council with a total precept of £93,557 for 2018/19, to spend on worthwhile projects within the community.

### 132 Welsh Government – Appropriate Sum under Section 137(4)(A) of the Local Government Act 1972 Section 137 Expenditure: Limit for 2018-19

It was noted that the appropriate sum for the purposes of section 137(4)(a) of the Local Government Act 1972 (the 1972 Act) for Community and Town Councils in Wales for 2018-19 is £7.86.

Section 137(1) of the 1972 Act permits each Community or Town Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of and will bring direct benefit to the area or any part of it or all of some of its inhabitants, providing that the benefit is commensurate with the expenditure. Community and Town Councils are also permitted under section 137(3) to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2017-18 will be £7.86 per elector.

# 13,616 electors (as at Jan 2018 CCBC) x £7.86 = £107,022

# 134 Projects

(i) Project Summary was tabled and noted.

- 370 Bus shelter in layby near Cross Inn Resolved: Council agreed not to proceed due to objections from neighbouring properties.
- 363 Bus shelter o/s Derwendeg Primary Resolved: Council agreed to remove this proposal from the project listing for the time being.
- 360 Compost toilet clerk to enquire with Ranger on the usage of the toilet.
- 361 Gelligaer Giant clerk to organise 2 further readings and creative writing workshops for Glyngaer Primary and Derwendeg. Clerk also to make contact with M Jones regarding the writing of another book funded by the community council

(ii) New project proposals:

- Bus shelter at Penybryn, near The Fox & Hounds (deferred from last meeting)
  Resolved: Council agreed to the installation of a bus shelter in this area following consultation with residents at a cost of between £3,000 £5,000.

**Resolved:** Council agreed that a family day trip to the beach from Ystrad Mynach take place this year. Cllr M James and Cllr A Angel to distribute flyers and accompany the residents on the trip at a cost of £295

## 138 Welsh Government Independent Review Panel - Review of Community and Town Council Sector in Wales

Council responded to the 4 following questions posed by the panel:

Q1. What should Community and Town Councils be responsible for?

A1.Community & Town Councils should have the flexibility to decide what services they should provide according to local need.

Q2. How should they operate?

A2.Community & Town Councils should be open and transparent and keep residents informed. They should encourage residents to take an interest in their activities. They should run

professionally with, if at all possible, a trained clerk and financial officer.

Q3. What's standing in their way to deliver for the local community?

A3. Lack of financial knowledge and other resources. A lack of information about activities of other statutory bodies.

Q4. How do councils ensure they best represent their local community?

A4. By being accessible to local residents and ensuring residents know of their existence through newsletters, websites and social media, and encouraging residents to make their views known.
