Members Resolved:

- (a) Financial Assistance due to increase in spend and anticipated spend to 31st March 2016, as a result of all applications received to date and anticipated applications, council agreed to vire £4k financed from additional income received, to increase Financial Assistance budget heading from £8k to £12k
- (b) Projects if all agreed requests for project funding are paid before the end of the financial year the budget will be exceeded by approximately £14k, and the council may want to consider further requests for project funding up to the 31st March 2016.

 Therefore following the clerks recommendation, council agreed to finance any additional project funding up to £20k from the councils balances of approximately £32.5k

122 Caerphilly's Budget Challenge – this item is deferred until December's meeting

Residents across the Caerphilly county borough are being given the chance to have their say on proposals to deliver over £12.4million in council savings next year (2016/17).

On Wednesday 14th October Caerphilly county borough council's Cabinet agreed a list of draft savings for the next financial year and these are now be subject to a period of widespread public consultation. The proposals also include a 3.9% increase in Council Tax for 2016/17. The budget consultation runs for 12 weeks, from: Monday 19th October - 8th January 2016

123 Project Update

- (i) Pantomime posters have been displayed in shops, noticeboards and website and tickets are selling well. An announcement will be made at the Christmas fayre.
- (ii) Ystrad Mynach Christmas Fayre Cllrs: J Pritchard, T Parry & D Cushing will make themselves available to assist during the day if required.
- (iii) Christmas Lighting Council ratified additional spend of £53 to insure all figurines and rope lights and public liability. Cost of £126.46 for 2016/17
- (iv) School solar project Meetings have been held with Procurement services to develop the tender and contract for the work.
 The tender has been issued and will remain open until December 4th 2015.
 All submissions will be reviewed during the week commencing December 7th to start the process of awarding a contract. This will include an evaluation of election/award tenders, Health & Safety/ Insurance checks and a few procurement procedures.
 Once the contract has been awarded the Community Council will need to agree the scale of the work based on the costs for the surveys and installations.
 The work will then be undertaken between January and March 2016.
