87 Healthy Child Wales Programme ~ Presentation

Cllr Nicola Quarry delivered an interesting presentation on Healthy Child Wales Programme. The programme aims to deliver a universal service to all families through Health Visitors, with a renewed focus on the prevention of child poverty, long term chronic disease and preventing ill-health. Members agreed that a good service should be offered to all children, but emphasised the importance of concentrating money and resources on areas of deprivation.

Communities First, currently under review with the Welsh Government, largely funds Flying Start which is a vital service for deprived families, making a positive impact on pre-school children in relation to cognitive and social skills.

Also highlighted were the current recruitment and retention issues within the Health Visitor profession.

Cllr Nicola Quarry will update Council with any further developments within the programme at a future meeting.

94 2018 Review of Parliamentary Constituencies in Wales Initial Proposals

Members noted the Commission's Initial Proposals Report is available on www.bcomm-wales.gov.uk and representation period ends on 5th December 2016 In summary, the Boundary Commission has proposed that a county constituency 'Merthyr Tydfil and Rhymney' is created from the electoral wards within the existing Caerphilly county borough to include Hengoed (3,374), St. Cattwg (5,400) and Ystrad Mynach (3,935).

A further county constituency 'Caerphilly' is to be created from the electoral wards within the existing Caerphilly county borough to include Llanbradach and Caerphilly in with Newport. Members strongly objected to the proposals and expressed their concern that the proposals would bring about an area being split between the police forces, with Gwent Police and South Wales Police and likewise with the health boards, split between Cwm Taf University Health Board and the Aneurin Bevan Health Board.

Members suggested that we remain as we are, with an MP representing all of our deprived communities within the valleys of the Caerphilly borough. The clerk will respond to the consultation, indicating our strong objections.
