Minutes of the ORDINARY FULL COUNCIL MEETING of Gelligaer Community Council held on Wednesday 27th November 2019, 7.00pm at the Council Office, Llwyn Onn, Penpedairheol.

Chair Cllr Judith Pritchard warmly welcomed everyone to the meeting

A minute silence was observed in respect of Cllr Donna Cushing's partner Mr Dan Orlandea who had sadly passed away. Dan was a devoted family man and served the community as a 1st Responder and Ambulance Driver. He will be sorely missed and our thoughts are with Donna and her family.

Mrs B Miles in her capacity as Secretary to Gelligaer & Merthyr Commoners Association, and not as Caerphilly County Borough Councillor, was invited to speak.

Mrs Miles explained that the Association, with a membership of 85, had submitted an application for proposed works to the Common to alleviate the problem of fly tipping and illegal off road by 4x4's in the main. Proposed works includes replacing old fencing with native deciduous hedges, followed by a bank and ditch in front of the existing fence. Trees are to be planted and will be temporarily fenced off until mature.

Other works proposed consisted of a combination of restoring and creating ditches parallel to the road no deeper than 1.5m with bunds. It was felt that too many horses were on the common and the Association would work with bona fide horse charities in trying to find suitable homes. Fly grazing and uncontrolled breeding resulted in bad breeding and fighting. Conditions on the Common can be harsh. It was suggested by some members that CCBC have brought fly tipping on themselves due to increased charges and amenity site closures. It was suggested that mounds and ditches would make the Common inaccessible to visitors/walkers. However it was explained that pathways would be created.

Mr Phillip Davies from the Welsh Horse and Pony Charity Group was invited to speak and explained that their group worked closely with British Horse Society, RSPCA and other bodies and at all times had the welfare of the horses at heart. He explained that creating mounds, ditches, fencing and walling would interfere with the natural migration of the horses. In some areas it could potentially divert ponies onto the carriageway with no means of easy escape back onto the Common. Due to the open cast mining traffic has increased significantly and signage to reduce speed and other traffic calming measures would be helpful, but has not been proposed within the application. A member suggested that the proposed ditches would not deter large vehicles and illegal off roaders would relish the challenge on offer, and those wider deeper ditches, which the animals could navigate may be an option. It was decided that members would consider this matter further under minute no. 119

Mrs Miles and Mr and Mrs Davies were thanked for their attendance and subsequently left the meeting.

116 Defibrillators – Register and Maintenance

The British Heart Foundation have developed The Circuit – the national defibrillator network, to give those who have suffered a cardiac arrest, the best chance of survival by linking a national network of defibrillators to every Ambulance Service in the UK.

The Circuit will also help you to look after and maintain your defibrillator. You'll receive regular reminders to check that your defibrillator is ready to use and that the pads are in date, be able to connect with other guardians in your area and even organise for someone to check it if you're likely to be away.

It's replacing our existing Welsh Ambulance Service defibrillator database so it's important you register your defibrillator so we know where it is and if it is available to use in an emergency.

Registering your defibrillator on The Circuit is quick and easy to do - just make sure you have to hand the following details:

- its location and surroundings
- brand, model and serial number (usually on the front of your defibrillator)
- times when its accessible
- pads expiry dates
- confirm it is displaying its ready signal
- access code (if applicable)

(iii) Appendices 1,2,3 - 2020/21 Draft Savings Proposals were received and the following comments, in order of priority with the top being most important, are to be relayed to CCBC.

<u>D09 Public Protection (£20k)</u> – Review pest control fees and charges and introduce a charge for rat treatments

Opposed - because if charges are applied, rat sightings and infestations will go unreported, thus becoming a public health issue.

C28 Corporate Policy (£80k) – Reduction in voluntary sector budget
Opposed – Gelligaer Community Council abhors cuts to the voluntary sector. Caerphilly
County Borough Council should be looking to support the most vulnerable people in our
communities. Implementing cuts will undermine the invaluable and supportive work that
these organisations (CAB, Gavo & Groundwork) carry out in the community at a time when
the Council are looking to the private sector for services Council provides, especially to the
vulnerable. Citizen's Advice is a life line to the most vulnerable in our communities. Lives
would become desolate and wretched without these services. We urge you to support our
most vulnerable by removing this cut from the budget in its entirety.

<u>{D13 Catering (£28k)</u> – Increase price of meals by 25p from April 2020 <u>{D14 Catering (£54k)</u> – Increase price of secondary school meals by 10 from April 2020 Opposed to D13 & 14 – on the grounds of child poverty. We have pockets of high deprivation in our area and we are conscious of the value of a decent school meal for our children, in terms of benefitting their physical and mental well-being.

<u>C16 Community & Leisure Services (£10k)</u> – reduction in playground maintenance budget Opposed to the reduction on health and safety grounds. CCBC could potentially see an increase in insurance claims.

<u>C25 Public Protection (£24k)</u> – Decommission of all BT line rental cameras Opposed to the proposed decommission of 6 cameras at Pengam Station on the grounds of highway safety due to the inevitability of vehicles flooding the adjoining streets.

<u>C29 Corporate Policy (£11k)</u> – delete remaining technical assistance budget Opposed because it will have a detrimental effect on the voluntary sector again, preventing many from applying for grants to external bodies, often securing grants on worthwhile refurbishment projects to their community buildings.

<u>C30 Corporate Policy (£6k)</u> – further reduction in the Well-being budget Opposed as this could undermine partnership working within our communities.

<u>D08 Waste (£25k)</u> – increase charges for bulky collections (from £16 to £25 for 1 to 3 items) Opposed as the increase is too high too quickly which could have an adverse effect and be counterproductive, with a rise in fly tipping. Suggested increase to £20.

C18 Community & Leisure Services (£32k) – 50% reduction in public rights of way budget. Opposed on the grounds of health and safety. Walking has many health benefits and should be encouraged. Reducing maintenance of our public rights of way could compromise safety.

<u>C23 Community Centre (£18k)</u> – reduction of 1 hour Caretaker support across all centres Opposed: Gelligaer Community Council would oppose any attempt to transfer the responsibility of structural maintenance and gas, electric and water installation to the Community Centre Management Committee.
