Bydd arwyddion yn cael eu gosod ar y safle 7 diwrnod cyn y bydd y gwaith yn cychwyn i hysbysu'r cyhoedd am ba rannau o'r ffordd yr effeithir arnynt a'r amseroedd y bydd y cyfyngiadau ar waith a bydd yr wybodaeth ddiweddaraf hefyd ar gael ar wefan y Cyngor.

Bydd llwybr arall ar gael ar hyd A472, Commercial Street a Penallta Road.

Bydd mynediad ar gael i'r gwasanaethau brys a phreswylwyr.

Y rheswm dros wneud y Gorchymyn yw caniatáu i addasiadau gael eu gwneud i'r Gorchymyn traffig unffordd arbrofol a'r llwybr beicio.

**Lewis Street, Ystrad Mynach  
Temporary Prohibition of Driving  
Order 2021**

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Lewis Street, Ystrad Mynach.

The proposed Order will commence on 1st March 2021 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. The work will commence on or as soon after 1st March 2021 as possible and will remain in place until the works, which are likely to take 1-2 weeks, have been completed.

The road closure will be immediately followed by further temporary traffic regulation orders which will be advertised shortly. Advance signage will be placed on site 7 days before work will commence to inform the public which sections of road will be affected and the times the restrictions will be in operation and updated information will also be available on the Council's website.

An alternative route will be available via A472, Commercial Street and Penallta Road.

Access for Emergency Services and residents will be maintained.

The reason for making the Order is to allow for modifications to be made to the experimental one-way traffic Order and cycle track.

The order is required by Caerphilly County Borough Council.
