126 Welfare Wednesday – Penalita Rugby Club Mental Health Hub

With mental health on the increase due to lockdown, the cost of living crisis and other pressures, demand is outweighing supply with services unable to cope. Clare Jackson, Welfare Officer for Wish 2 has set up Penallta Rugby Mental Health Hub. Initially set up for the youth of the club, Clare is now in the early stages of looking to open it up to all ages and the wider community.

They have the support of Libanus, Mind, 2 Wish, Payprus, Tackle your Thoughts and so many more agencies plus drug and alcohol support services too. There are no paid staff just people from the agencies coming together.

Members liked the project and advised that the clerk would forward further information and contacts for the initiative to progress further.
