Minutes of the ORDINARY Full Council Meeting held on Wednesday 29<sup>th</sup> June 2022 7.00pm at Gelligaer Community Council Office in a MULTI-LOCATIONAL format in accordance with the provisions of the Local Government and Elections (Wales) Act 2021.

Chair Cllr Martyn James welcomed everyone to the meeting and invited our Community and Environmental Champion Mr Daniel Lewis to speak with members

## 27. Mr Daniel Lewis - Gelligaer & Merthyr Common

Daniel Lewis introduced himself to members and spoke about the illicit tipping issues on Gelligaer and Merthyr Common. Following a massive clean-up operation undertaken by Daniel, whereby he cleared 40 tonnes of rubbish from the common, he installed cameras along Bogey Road, Merthyr, which have proved to be very success with only two incidents of fly tipping occurring since. Recordings from the cameras are now being investigated.

Discussions took place around the Chicken Lane area which sited within the Gelligaer area of the common with the intention of funding the installation of posts and running costs for 4 cameras for the year under our Projects heading.

RESOLVED: Council agreed to fund 12 bags of post crete at approx. £6 per bag and further agreed to fund the annual running costs of £120 per camera x 4. Total cost: £552
