RESOLVED: Council agreed not to increase the precept for 2023/24 due to the cost of living crisis.

Training budget was reduced to £3.5k and monies vired from the Projects subject heading to Community Benefits subject heading.

Furthermore, earmarked reserves were discussed with the removal earmarked sum of £20k for the climate shop. Instead, Members agreed £9k be earmarked for School Environmental Projects, £6k increase for Orchards/Environmental Projects/ Tree Planting and £5k for Gelligaer Square improvements to include planters and mural etc.

Clerk will present the agreed revised budget and earmarked reserves at our next meeting in February.

The results of the consultation will be reported to meetings of CCBC Cabinet and Full Council at the end of February when the final budget will be considered.

RESOLVED: In response to CCBC's draft budget proposal, Gelligaer Community Council do not agree to the 7.9% increase in Council Tax in view of the fact that you have a considerable amount in reserves, some of which is earmarked, and an underspend from last year.

We would like CCBC to reconsider the following:

CS10 - We would like to see the Empowerment Fund continue it was extremely useful to community groups, making worthwhile projects possible at grass root level. It was such a good initiative (very much like the Area Forum Funding) but needs time to bed in and establish itself properly.

CS14 - We object to the cuts to voluntary organisations such as GAVO, Groundwork and CAB. These services are needed more than ever during this cost of living crisis and should be supported.

EE4 – we oppose the withdrawal of subsidy for the Blackwood to Ystrad Mynach Rail Link bus service. Other solutions should be explored like opening up the service to non rail users.

EE6 - We oppose the increase in charges of sport pitches as it flies in the face of the Welsh Government's Well-being of Future Generations Act which requires public bodies to consider carefully the long term impact of their decisions and to work better with communities in preventing health inequalities.

EE15 We object to the cuts to Community Centres just when we have emerged from the pandemic and people are finding the confidence to re-engage with others through activities held at our community centres and halls.

ELL13 We object to the loss of an Educational Psychologist a crucial role in supporting our children and we feel should be filled immediately.

133. Appropriate Sum under Section 137(4)(a) of the Local Government Act 1972 Section 137 Expenditure Limit for 2023-24

Members noted that the appropriate sum for the purposes of section 137(4)(a) of the Local Government Act 1972 (the 1972 Act) for Community and Town Councils in Wales for the financial year 2023-24 is £9.93.

Section 137(1) of the 1972 Act permits each Community or Town Council to incur expenditure for purposes for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure incurred.

Community and Town Councils are also permitted under section 137(3) to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 will be £9.93 per elector.

13,767 electors x £9.93 = £136,706.31 which is the maximum expenditure for s137(1) and s137(3)
