"I am writing to confirm that members of Gelligaer Community Council unanimously objected to planning application 22/0175/NCC and the proposed extension to hours of operation on the grounds that it would cause a public nuisance.

For those members that may not be aware, gradual incremental planning applications over many years at Gelliargwellt Farm have resulted in a small but typical mixed farm growing into in this massive waste management and quarrying development encroaching closer to just within 300m of people's homes. Dust and noise which local residents endure daily does not affect just one person, it affects families including children, spanning two villages.

The daily grind of noise and dust contributes to considerable hidden suffering, with increased levels of stress, anxiety and depression experienced, which cannot be underestimated as a factor in causing long term physical and mental health conditions.

Decisions have consequences and we urge the Committee to consider the basic rights of the residents to quiet enjoyment which this proposal will not allow".
