Guidance on taxation

It is not within the remit or authority of the Panel to provide specific advice on matters of taxation. Advice can be provided by One Voice Wales and guidance is available on the HMRC website.

The £156 should fall under the statutory provisions of section 316A ITEPA: Income Tax (Earnings and Pensions) Act 2003 (legislation.gov.uk) and the current amount that can be paid without attracting a tax liability is £6 per week: Expenses and benefits: homeworking: Homeworking expenses and benefits that are exempt from tax - GOV.UK (www.gov.uk).

A council resolution is required to determine:

- (i) How the payment of consumables are paid a one off payment is preferable to be made by the clerk, additional consumables costs over £52 can be claimed with receipts throughout the year.
- (ii) Mandatory Senior Role Payment of £500 to determine that the Chair be in receipt of this payment for 2023/24 and to consider if other members, up to 7, should be in receipt of it. It does appear that the Mandatory Senior Role Payment of £500 plus the Basic Mandatory payment of £156 exceeds the threshold of £6 per week and is therefore taxable the clerk will establish the appropriate procedure to pay the tax.
- (iii) To determine a payment (up to £500) to the Vice Chair for 2023/24 (last year it was £100)
