Chair Cllr Teresa welcomed everyone to the meeting.

90. Apologies

Apologies were received from Cllr Maryn James due to illness.

91. Declarations of Interest

Councillors and Officers were reminded of their personal responsibility to declare any personal and/or prejudicial interest(s) in respect of any item of business on this agenda in accordance with the Local Government Act 2000, the Council's Constitution, and the Code of Conduct for both Councillors and Clerk.

Chair Cllr Teresa Parry welcomed Bute Energy to the meeting

92. Twyn Hywel Wind Farm – Bute Energy

Members received and noted a comprehensive, informative and interesting presentation on the proposed Twyn Hywel Wind Turbine development. In summary:

- The project responds to the Climate Emergency and will help local communities live modern electric lives, while supporting the Welsh Government's target for electricity to be 100% renewable by 2035
- The Twyn Hywel Energy Park will include up to 14 wind turbines up to 200m total height, generating 92.4MW of clean, green energy, enough to power the equivalent of 81,000 households a year.
- The clean energy generated at Twyn Hywel will help displace approximately 5.6 million tonnes of carbon dioxide, the equivalent to taking all cars off the road in Caerphilly County Borough Council each year.
- The majority of the proposed Energy Park site sits within a Pre-Assessed Area for large-scale onshore wind energy according to the Welsh Government's National Development Framework, Future Wales: The National Plan 2040
- Community Benefit Fund in the region of £693,000 totalling more than £30 million over the up to 45- year operational life of the project.
- The aim is to keep as much of the investment in Wales for the benefit of local communities. Procurement will focus on the local supply chain, and each contract awarded during development and construction will see partners sign up to the Bute Energy Social Value Standard

Members raised many questions surrounding the baseline measurement of biodiversity and habitat etc. It was stated that the grazed land is quite degraded which creates opportunities for biodiversity net gain. The number of turbines were reduced to 14 and locations changed to minimise visual impact. All components can be recycled following its 45-year life span, as the most prominent material is steel. Drainage regulations set a high bar and hydrologists and drainage team have assessed run off over a 2-year period. There will be soakaways on the periphery of the bespoke tracks accessing the site, to alleviate issues further down. A bespoke track made with Type 1 aggregate will be constructed for accessing the site, as opposed to roads, for maintenance purposes during the lifetime of the project and for decommissioning.

Community Benefit was discussed, and Bute Energy will return for further discussions around this.

Nelson's local resident Ms Winter was invited to speak.

Ms F Winter asked the Bute Energy team whether the access roads to the turbines were permanent or temporary. Bute Energy confirmed that the access roads to the turbines would be permanent for the duration of the project as they would need access to maintain the turbines.

Members thanked Bute Energy members and Ms Winter for their attendance and they subsequently left the meeting.

97. Matters Arising

In respect of planning application case ref: 23/0617/FULL Minute no. 88 and our comments submitted to CCBC's planning department, members received and noted the response from consultants acting of behalf of Bryn Compost.

1. Intensification of use

The proposal does not propose additional throughput but seeks to accommodate changes which optimise the site's capacity. The level of throughput will continue to be controlled through the site's permit with NRW. The technical assessments undertaken to support the application (i.e. Landscape and Visual Statement and Air Quality Assessment) have considered the proposals in the context of the cumulative development at the site and find that the proposals are acceptable.

The benefits of the site's operation and its importance to the Council is highlighted in the Council's planning policy guidance within the Ystrad Mynach Masterplan SPG (see Paras 5.23 and 5.24) and has been recognised by a planning inspector considering the site as part of a previous appeal:

"My attention was also drawn to the significant benefits in terms of its contribution to wider waste and sustainability objectives. The evidence was that the facility plays a key role in receiving green and food waste collected from residents. The Council has not raised any issue in relation to the facility in terms of the strategic policies of the Local Development Plan and I have no reason to disagree... The appellant points out that this is the waste site on which the Council relies to service its waste collections for recyclables and organic waste. It is disingenuous for the Local Planning Authority to state that this is not a planning matter. It is clearly a matter of importance to its waste collection functions." (APP/K6920/A/18/3203497 Appeal Decision)

2. Visual amenity

The submitted Landscape and Visual Statement prepared by McQuitty Landscape Design concludes that:

"The location of the proposed AD amendment development benefits from a high degree of enclosure from existing consented buildings and structures which themselves are set within a strong framework of previous earth mounding and mitigation planting, much of the latter now well established.

In this context, the proposed development represents a very small landscape and visual change which will result in generally negligible landscape and visual effects on the surrounding landscape and identified visual receptors.

It is our view therefore that this proposed development would have no unacceptable landscape and visual effects, including on the geographically extensive locally designated Mynydd Eglwysilan Special Landscape Area."

3. Air and ground pollution

In terms of air pollution, the air quality assessment concludes that the development will have an insignificant impact on Nelson Bog SSSI. The author of the report has provided the below summary of the assessment methodology undertaken:

Computer based atmospheric dispersion modelling has been used to determine the pattern of discharge from the Bryn Power installation enabling an assessment of the impact of the existing and proposed plant on local air quality.

Atmospheric dispersion modelling provides a means of estimating the potential impacts of emissions, by modelling the dispersion of a plume or plumes exiting a chimney in relation to a number of key parameters. This enables the calculation of an estimated contribution to ground level pollutant concentrations arising from the releases, prior to the development or authorisation of new or modified plant. The model applied was the CERC ADMS software (version 5.2) which is one of a number of models used routinely in the UK for this sort of application.

The data inputs included emissions releases from each of the relevant combustion units at the site – it is therefore based on actual readings attached to the existing CHP installations. Where extractive test data were available for the processes, information on the release characteristics such as temperature and volumetric flow of the flue gases were applied to the model. Where no such data was available, for example for the new processes, data on the anticipated releases when operating at maximum capacity was obtained from the technology providers.

Pollutants have been assumed to be released concurrently and continuously at the maximum permitted levels. This should result in a worst-case assessment as the processes should emit pollutants up to the specified emission concentrations but should always aim to remain within the permitted limits. Assuming that plant discharge pollutants at the maximum permitted concentrations on a continuous basis is therefore generally considered to result in a more conservative assessment, rather than modelling measured emissions which are often lower than the permitted limit.

The proposal does not have any impact on the surface water drainage regime. The area of impermeable surface will not increase as a result of the development, and therefore the ability of the site to absorb rainwater is not affected. The site is already served by existing drainage infrastructure and the development will not directly affect the function of this system, its ability to take rainwater or the volume of rainwater that it is required to carry. The proposals fall below the threshold requiring SAB approval. The application will therefore not have any impact on drainage.

4. Highway considerations

The proposals do not result in the overall site processing more waste than presently received at the site as regulated by the relevant Environmental Permits, but rather enables it to be utilised more efficiently. Accordingly, there will be no increase in vehicle movements. Likewise, this application does not seek any extension to the existing controlled hours of operation. Construction impacts will be adequately controlled.
