(ii) Greenhouse

Council considered the proposal but requested further information and costings for the renting a community plot at the Vicarage Allotments and the supply and installation of a greenhouse for the safe storage of plants over the winter and to potentially bring plants on in the summer. A water butt will also be required to collect rain from the greenhouse and a composter for our green waste which we currently bag for CCBC to remove. The greenhouse will serve our town and villages. The clerk will investigate further.

(iii) RBL Silhouettes

(a) Greenhill Primary Memorial Garden – an email from Greenhill Primary was received and noted

RESOLVED: Council agreed to the purchase of an RBL silhouette for the school's memorial garden.

(b) Glyngaer Primary Memorial Garden

RESOLVED: Council agreed that the school be invited to put their request in writing to the community council.

(iv) Ystrad Mynach Calendars 2024

Council received and noted email from Mr Phil Morris in relation to purchasing the calendar with proceeds supporting local groups.

RESOLVED: Council felt that we regularly support local groups and charities with grants and donations and supported the Chair's donation of £50 towards the production of the calendar.

(i)The Christmas tree lights failing to switch on were very disappointing despite assurances from the contractor that all was well.
