Gelligaer Community Council objects to this application on the grounds that an extension may interfere with visibility for vehicles turning left out of Hospital Road onto Pengam Road. This is such a busy crossroads with cars often parking on the double yellow lines close to the junction, therefore posing a hazard. Restricting visibility further with an extension may exacerbate the issue.

Furthermore, an extension would have a visually negative impact, contrasting greatly with neighbouring properties and not in keeping with the character of the properties on the street.
