83. Public Participation

Chair Cllr Haydn Pritchard invited Mr Rob Young from Glaynant Memorial Hall to speak with members.

Members ratified the following business due to insufficient time for members to comment on recent CCBC consultations, and CCBC conducting the surveys during the august recess, which required the clerk using her delegated powers to respond on behalf of the Community Council:

Direct Meals Services

Gelligaer Community Council are opposed to the cessation of Direct Meals Services in the community on the grounds of:

- 1. The service provides a host of benefits to some of our most vulnerable members in the community, such as people with disabilities, Ill health and the elderly.
- 2. In many cases, the meals provided by Direct Meals Services will be the only source of nutrition they have.
- 3. The daily visits from the staff are in many instances the only contact the users have with people. Therefore from a social perspective, the visit is more than just food as the interaction between user and staff can help to alleviate loneliness and isolation.
- 4. Staff can also detect if the user is unwell and can alert the emergency services if assistance is needed. The multifaceted role of the staff should not be underestimated.
- 5. Providing meals and regular interaction with the users does facilitate independent living, putting less strain on other departments.
- 6. Removing this invaluable service will undoubtedly put extra strain on social services, therefore monies saved in one department could potentially increase the resources and costs in another.

Llancaiach Fawr Manor

Gelligaer Community Council strongly object to the proposed closure/mothballing of Llancaiach Manor House due to it being a significant historical and cultural landmark in the Caerphilly borough for the following compelling reasons:

1. Historical Importance

The Manor, which is a grade I listed building, and considered to be one of the most important gentry houses to have survived the 16th and 17th century period. It is one of the finest examples of a semi fortified Manor house in Wales and has significant historical value.

2. Educational value

The Manor serves as a living history museum, providing educational opportunities for schools and visitors to learn about life in the 16th and 17th century. It offers a unique immersive experience that brings history to life.

3. Tourism and Economy

As a popular tourist attraction Llancaiach Fawr Manor contributes to the local economy. It attracts visitors from all over, supporting local businesses and generating revenue for the area.

4. Community Engagement

The Manor is a focal point for community events and activities such as weddings, birthdays, Sunday lunches, exhibitions and award ceremonies to name a few. It hosts various events throughout the year fostering community spirit and providing a venue for local gatherings.

5. Cultural Heritage

Preserving Llancaiach Fawr Manor is crucial for maintaining the Welsh cultural heritage of the region.

6. Employment

The Manor provides jobs for local residents. Closing it would result in job losses and will negatively impact the livelihoods of those employed there.

Given these reasons it's clear that Llancaiach Fawr Manor holds significant value beyond just its financial cost. Its closure would be a loss to the community, the local economy and the preservation of Welsh heritage.

RESOLVED UNDER DELEGATED POWERS: Gelligaer Community Council would like to object to planning application 24/0525 - Enable extension to existing quarry operations including

landscape bunds with associated works and erect sports pitch and circular walkway footpaths on the following grounds:
The development will have a significant and long-lasting impact on residential amenity. The impact on health and mental wellbeing of the current quarrying works is well documented. Residents have had to deal with the constant noise dust and traffic for a significant number of

years; it's unacceptable to extend this for 20+ years in to the future. The cumulative impact on residential amenity from the various works on the site should be considered as part of the application.

• The quarrying work will impact significantly on air quality in the area which will have a detrimental impact on residents. No independent monitoring has been conducted of the surrounding air quality. Given its potential for significant harm the true extent of its impact needs to be explored further before planning permission is granted. The 250m buffer zones set in the LDP should be recognized as a minimum and not a target. The landscape bund is still in development and it will be a significant number of years before the trees in this area are mature enough to provide any genuine protection and or privacy to residents.

88. Matters Arising cont'd and ratified:

- The air quality Impact report states that extraction will take place at a 300m distance from local dwellings. It is unclear whether the buffer zone includes the haulage routes or the quarrying only

 we would like clarification on this prior to planning permission being granted.
- The extent of the impact on water levels and the subsequent impact on the Nelson Bog SSSI
 has not been considered in enough detail. Mitigation reports and further study should not be a
 condition of planning but completed prior to planning being granted.
- There will be a significant and unacceptable impact on protected species those at Nelson bog and those that have been discovered on site. These include red list birds, European protected Great Crested Newts and reptiles. CCBC operate a reptile trans relocation site in the grounds adjacent to the development - any development would likely have an impact on this habitat.
- Within the application there is a proposal to remove significant amounts of peat within the site. Damaged peatlands are a significant source of greenhouse gas emissions. The extraction of water from peat sources and its disturbance will result in significant levels of CO2 release into the atmosphere from the peat which has been absorbing CO2 for thousands of years. Peatlands can absorb significantly more CO2 than any other land type and should be afforded our protection now for the benefit of future generations. Caerphilly's LDP aims to reduce greenhouse gas emissions from developments.

Quarrying activity should only take place where there is a demonstratable need for the stone – particularly as in this case where it is likely to impact significantly on the surrounding area for a considerable period of time. CCBC's LDP annual monitoring report 2023 shows that there is already significant stone of similar grade available beyond the required 10 year landbank. This shows that the extension to Bryn Quarry is unnecessary and should not go ahead.
