Gelligaer Community Council continue to have significant concerns, along with CCBC's Ecology Officer and NRW, regarding this application in relation to land contamination and controlled waters and protected sites. We therefore strongly object on the grounds that no new information has been forthcoming and our previous comments below are upheld.

Gelligaer Community Council strongly object to planning application 24/0855/FULL on the grounds of overdevelopment. It will negatively impact the local area with the loss of amenity space.

It will have an overbearing impact on the street and will alter the character and appearance of the locality. The negative impact on local ecology will be profound as it will significantly disrupt local wildlife habitats as the hedgerows provide crucial corridors for many species. The proposed development will lead to a decline in local biodiversity.
